***** If a Men's team loses in the West Qualifier and enters the East Qualifier, the fee will be TBD but they must retain 3 of the original team. If 3 members of the original team are not entered this will be considered a new team and the entry fee will be TBD and new players will pay the CCA Competitor Fee.**
